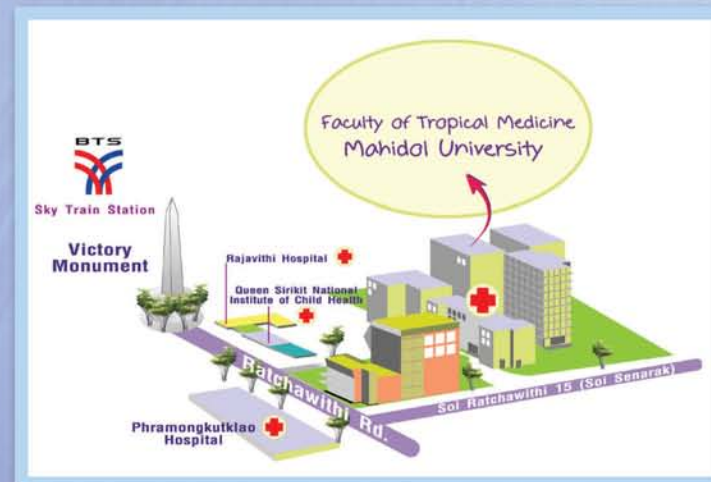

### **Educational Goal of the Course**

This international course on Environmental Health Impact Assessment aims to develop professionals not only equipped with knowledge and skills needed to conduct a thorough environmental health impact assessment but also professionals imbued with a holistic view of health and health development and advocates of environmental health and healthy public policies. As EHIA professionals, they are expected to make critical decisions based not only on scientific evidence but also according to what is legal, moral, and ethical.

### **Educational Philosophy**

This training course will be guided by adult learning principles and will therefore utilize teaching learning strategies that will maximize participants' prior knowledge and experiences. This would mean using a problem-learning approach in knowledge and skills development.
